



## SHORT-TERM EQUIPMENT HIRE AGREEMENT

CROWN INDUSTRIES® ("**the Company**") agrees to allow the person, organisation or company ("**the Customer**") noted in the Schedule, the short-term use of the item ("**the Equipment**") listed in the Schedule subject to the following terms and conditions:

**OWNERSHIP AND TITLE**

1. Ownership and title of the Equipment remains with the Company.
2. The Customer understands and accepts the Equipment is being provided to the Customer on a short-term hire basis and at no stage does the Customer have right of ownership or title to the Equipment.
3. The Customer accepts custodianship of the Equipment upon agreeing to the terms and conditions herein and taking physical possession of the Equipment.

**RISK**

4. Upon accepting custodianship of the Equipment, the Customer agrees that all risk associated with the use of the Equipment rests with the Customer whilst in the possession of the Customer.
5. The Customer agrees that the Customer will be liable for any damage to or loss of the Equipment whilst in the possession of the Customer.

**EQUIPMENT USE**

6. The Customer agrees to use the Equipment only for the purpose provided in the Schedule.

**HIRE TERM**

7. The Customer agrees the Hire Term is inclusive of the date of collection and the date of return. The Hire Term is exclusive of the date of return in the event the Customer returns the Equipment to the Company before 10am on the agreed date of return.

**HIRE FEES**

8. The Customer agrees to pay the fees as stated in the Schedule and to pay such fees in advance by Credit Card.

**STAND-ALONE WEEKEND RATE**

9. The Customer offers a Stand-Alone Weekend Rate which is specific to Customer collection on a given Friday and Customer return the following Monday before 10am.
10. The Stand-Alone Weekend Rate does not include long weekends. Standard daily rates apply to long weekends.

**RETURN CONDITION**

11. The Customer agrees to ensure the Equipment is clean when returned. The Company reserves the right to charge a cleaning fee of \$15.00 plus gst where the Equipment is dirty upon return.

**SECURITY**

12. The Customer agrees that the Company will maintain the Customer's Credit Card Details as security during the course of the short-term hire period.
13. Upon return of the Equipment on or before the agreed date and time, the Company will destroy all records of the respective Customer Credit Card details.
14. In the event the Customer does not return the Equipment on or before the agreed date, the Customer agrees that the Company may debit the Customer's Credit Card to the dollar amount nominated in the Schedule as the Equipment purchase price.
